**RULE NO. 3B: APPLICABLE FOR ADMISSION OF ORDINARY / LIFE MEMBER AS PER THE  
CONSTITUTION**

“ A competent and bonafide professional Instrumental musician who has attained the age of 18 years and with a minimum qualification of Std. X or its equivalent in any medium and a citizen of India and residing / living in Maharashtra State and who is not a member of any other body of Musicians, established for protective purpose and who is not working in any public, private or limited company or in any organization registered under the Companies Act. 1956 or a firm registered under the Indian Partnership Act. Or in a proprietors concern or in Government service, shall be eligible to become a member of the Cine Musicians’ Association on an application form prescribed by the Association.”
